H) As concisely as possible, please state why you feel you should be endorsed over the other candidate(s). What goals for the office you seek are most important to you personally? I have dedicated my public life to Independent Politics. Not only was I the only Alderman to publicly challenge Mayor Emanuel when his staff tried to limit my speech (I can provide Sun Times article per request), I was also one of 27 Alderman who signed a letter protesting specifics of his budget. I am a proud sponsor of the Clean Power Ordinance, the Lead Sponsor of the Ban the Plastic Bag Ordinance, and the author of the Boycott Arizona Ordinance because of their anti immigrant legislation. My political Organization- 1st Ward First (1WF)- INDEPENDENT Political Organization has an endorsement committee to question candidates on their independent credentials and recommend endorsements.

My goals are to take the two main responsibilities of a Committeeman into the public view. The first- slating candidates when there are vacancies, has for too long been a “back room” process. Although I favor special elections when these vacancies occur, for the time being I would propose the following: When a vacancy occurs, hold a number of public meetings with the candidates attending and speaking on their credentials. Have the community vote and use that vote to officially vote as Committeeman for that candidate. The second main responsibility of a Committeeman is to slate candidates for the Democratic Party. I would implement the same objective as stated above.

As Alderman, If I can not trust my Committeeman who has had zero (0) public meetings on the process detailed earlier in the questionnaire, and does whatever the Democratic Party Chairman tells him to do, it is my duty to run for this non paying position.
7. Have you or would you send letters to government officials soliciting jobs or promotions for individuals?

I know it is the “right” thing to say No, but I feel otherwise. My community is hurting and there are many QUALIFIED people who need employment. Come to any of my ward nights and see the dozens of people (mainly low income) who are desperate for jobs. They WANT to work. It is my DUTY, as Alderman and Committeeman to LEGALLY help ANY QUALIFIED individual gain employment. Whether that is in the Private, Public, or Government arenas.

10. What plans do you have to enhance voter registration and voter turn out in your ward? In my Aldermanic election, we registered over 500 new voters. At my satellite office that I have almost every weekend, we have a voter registration drive. It is easy to answer this question and say what you WANT to do. I have demonstrated what I have DONE and will continue to do.
11. Does your organization have/or will have members? If so how does one become a member? 15 Board members, over 100 at large members. A potential member needs to be recommended by at least two board members and have already participated in community projects (e.g. Clean and Greens, school fundraisers, Block Parties, etc.)
