As a legislator and a healthcare provider, I am able to articulate health related matters from both a patient and doctor's perspective. I feel that this will be very important as the discussion and legislation towards healthcare delivery and HMO reform continue. As State Representative, I have utilized this background to debate on issues ranging from parental notification to workers compensation. I believe this has made a difference in the legislative process. As a dentist for 17 years, I have established a private practice in an underserved area where the majority of my patients were children. This makes me unique as a dentist and a candidate.

Prior to servicing office, I lobbied state and congressional officials on behalf of issues that effect my profession. I am a past president of the Illinois State Dental Society's Political Action Committee, DENT-IL-PAC. I am also a small businessperson who has established two dental practices. H) As concisely as possible, please state why you feel you should be endorsed over the other candidate(s). What goals for the office you seek are most important to you personally?

As State Representative, I have represented and reach out to the entire district. Inclusive politics have proved successful to ensure that residents across the district have representation in Springfield who will address their interest in their community. Keeping to this commitment, I am the only candidate who has received signatures during the petition phase of the majority of the cities that comprises the 29th District. I have worked hard to reach out to those mayors who did not support me in last election. This effort has proved successful since nearly all mayors in the district have endorsed me for the 2004 election. I embrace the diversity of my district. I have been able to appeal to the different geographical, racial, political and economic boundaries. One opponent has supported the comments that the district is “cut for a African American” and is supported by divisive, machine-style politicians. These statements use race to polarize our community. The Chicago Tribune describes the other opponent as a Former Gang Member and convicted felon. Although Illinois allows convicted felons to participate in the electoral process, I believe my proven ability and experience to provide leadership across the region over the years in needed during this period of tremendous budget deficit.

My vision is to ensure that the same opportunities that were made available to me growing up will be available to future generations. Guaranteeing that citizens in the 29th Representative District enjoy the same economical growth and viability as in other areas is a major priority. A strong local economy will help ensure a stable job market, a stable tax base and a ultimately a better quality of life. To this end, my priority is to address the economic disparities compared to the northern areas of Chicagoland. Other priorities include initiatives in education, consumer protection and health care.

Economic Development

A fully functional third airport in the Chicago area has tremendous economic benefits. As an economic engine, it will create jobs and a strong tax base for the Southland communities. New jobs bring new business opportunities in the form of new hotel developments, rental car companies, restaurants and many other auxiliary services. In addition, and sales tax revenues all curve to boost Chicago’s economy and strengthen its tax base.

Education

Local property tax district is the primary source of school funding in the state of Illinois. The Equal Assessed Valuations (EAV’s), which represent the taxable property base for schools as certified by the Illinois Department of Revenue, is supposed to assure equal valuation treatment across all 102 Illinois counties. Currently 80% of all the school districts in Illinois are undergoing deficit spending. Therefore, schools are financially strapped to provide students with quality education with very little resources. The state should be the primary provider for educational funding. Until there is meaningful comprehensive educational reform package (EFAB recommendations, property tax swap, dedicated revenue source and/or a tax increase), then we are only left with band-aid approaches. Working with many local area superintendents, budget specialist, community groups, I have attempted to address this problem. Legislatively, I am the Chief Sponsor of HB750

Universal Healthcare

One in every ten children in Illinois does not have any form of health insurance and 1.3 million Illinois citizens have no health coverage and millions more are under-insured. Everyday more and more individuals are added to the list of the

non-insured due to loss of job, retirement, disability, and welfare transition. In addition, health care coverage is needed for the thousands of working poor in Illinois. The Bernadine Amendment eliminates these issues by guaranteeing universal healthcare coverage to all Americans. Matching Federal programs must be maximized. I will continue to push for expansion of family care, streamline Kid Care enrollment, maximize All Kids, and expand the Circuit Breaker program to help address the healthcare crisis.
